# MEMORANDUM OF UNDERSTANDING BETWEEN

# SUAN SUNANDHA RAJABHAT UNIVERSITY, THAILAND

## AND

# UNIVERSITY OF EAST ASIA, JAPAN

This Memorandum of Understanding is between Suan Sunandha Rajabhat University, Thailand (herein after "SSRU"), represented by the President: Assoc. Prof. Dr. Luedech Girdwichai and University of East Asia, Japan (herein after "UEA"), represented by the President: Prof. Dr. Koji Kushida. Both parties have regulations and conditions as following:

#### 1. Objectives

- 1.1 To strengthen cultural ties between the two countries.
- 1.2 To enhance the understanding and commitment between the educational institutions.
  - 1.3 To explore experience and vision of students and faculty

### 2. Frame and Method of Cooperation

- 2.1 Creating opportunities for mutually beneficial faculty research and development.
- 2.2 Exchange knowledge is on educational and research materials, including publications of mutual interest at the respective institutions.

- 2.3 Exchange students from each institution are admitted to enhance their educational careers; that courses to be taken by each student will be decided in consultation with the respected institution, according to that individual student's interests and needs and under the guidance of the respective academic advisor; that credits earned by students at the host institution will be recognized by the home institute.
- 2.4 The host institution will assist in the arrangements for accommodations for the exchange students. The students from either institution participating in this program are responsible for fees, books, transportation, and living expenses.
- 2.5 Further details of this program shall be worked out through ad hoc mutual consultation.

#### 3. Period of Agreement

This Agreement is effective on 13 July 2016 and shall be valid from the date of signing by both sides for 5 years (five years). If any institute would like to end the cooperation or change or extend the cooperation, they must inform the other institute within the specified time in advance and it must be recorded in writing. After both parties accept, the additional agreement will be attached and it will become a part of this agreement. This must be completed on or prior to 60 days before the due date in accordance with this Agreement.

The implementation of this academic cooperation, as well as activities and project management, confidential information, confidentiality, publishing and the cost of the implementation of the project depend on the project board's consideration on a case by case basis.

The agreement is made in two original copies which are completely the same between both parties, both parties have read and fully understand the contents therein, and accordingly sign their names and affix seals (if any) as evidence hereof with the presence of witness.
